RPM™ Prepaid MasterCard® Card

The RPM™ Prepaid MasterCard® Card is the no-check, no-hassle way to pay and be paid, letting the user [take control](#) of their money. These prepaid cards belong to the cardholder, not the company. RPM™ cards can be used by business owners and individual cardholders.

Business Owner

Issuing payroll cards is a fast and effective way to pay employees and contractors, perfect for those employees without bank accounts or credit cards. Simply direct deposit money to the employee's card account. The enrollment for business owners is easy and there is no minimum number of employees required. Any employee or any person age 18 or older that is a legal U.S. resident is eligible.*

Common uses for the RPM™ Prepaid MasterCard card include:

- ▶ Disbursements and settlements
- ▶ Reimburse business expenses
- ▶ Relocation expenses
- ▶ Household budgeting tool

Cardholder

Similar to prepaid credit cards and debit cards, the RPM™ card is a stored value payroll card that can be reloaded and it belongs to the cardholder, not the employer. Cardholders can have all or part of a paycheck from one or multiple employers directly deposited onto the card and a bank account is not needed.

- ▶ Keep within your budget; card is prepaid so you can't go over your spending limits.
- ▶ Eligible for the RPM™ Prepaid MasterCard card* even if a person has been rejected or turned away by a bank.

Reduce expenses. Eliminate paper checks and stamps used to send out paycheck and reimbursement checks and pay no fees to upload funds to cards.

Increase employee satisfaction. Employees have immediate access to their paycheck or expense reimbursement funds easing the stress of waiting for payments in the mail.

Cardholders add cash. Cardholders can add cash to the card through ACH, PayPal and Western Union in addition to the direct deposit from an employer.

Cardholders use to pay bills. Eliminate the hassle of getting cashier's check or money order by paying bills through the RPM card.

Eligibility. Anyone 18 years of age or older that is a legal U.S. resident is eligible for the RPM card, even if you do not have a bank account. No credit check required.*
